



LIMASSOL MUNICIPALITY
INFORMATION ON APPLYING FOR A CIVIL WEDDING
RUSSIAN

Couples wishing to conduct a civil wedding in Limassol Municipality must themselves apply to the civil wedding department in order to follow one of the two procedures:

1. Normal procedure

In this case the couple must apply to the Marriage Officer to do the application and arrange for the wedding after 15 clear days and not later than three months from the date of the application. (the cost is **€ 128.-**)

2. Swift procedure

In this case the couple must apply to the Marriage Officer for the application and arrange for the wedding, which will be prior to the elapse of 15 days.
(the cost is **€ 282.-**)

DOCUMENTS TO BE PRESENTED

- 1. PASSPORT**
- 2. RECENT CERTIFICATE FROM THE COMPETENT AUTHORITY OF THEIR COUNTRY FOR THEIR PRESENT MARITAL STATUS (VALID FOR 3 MONTHS FROM THE DAY OF ISSUE)**
- 3. BIRTH CERTIFICATE.**
- 4. DIVORCE CERTIFICATE.**
- 5. DEATH CERTIFICATE OF SPOUSE IF WIDOWED.**
- 6. AFFIDAVIT from the District Court in Limassol**

All certificates must be translated to Greek or English by an official translator.

Foreigners living in Cyprus over (3) three months must do an affidavit at the District Court and within the same week, present the affidavit to the Civil Registry and Migration Department (Nicosia) for a certification that during the period they are living in Cyprus they have not conducted a civil wedding.

- 3. BIRTH CERTIFICATE.**
- 4. DIVORCE CERTIFICATE.**
- 5. DEATH CERTIFICATE OF SPOUSE IF WIDOWED.**
- 6. AFFIDAVIT at the District Court in Limassol.**

All certificates must be translated to Greek or English by an official translator.
